

REACH Declaration of Conformity

Declaration with respect to EU Regulation (EC) No. 1907/2006 relating to the Registration, Evaluation, Authorisation and Restriction of Chemicals

According to Regulation (EC) No. 1907/2006 (REACH: Registration, Evaluation, Authorization and Restriction of Chemicals), which came into force on June 1, 2007, AGRO AG is a downstream user. AGRO AG only sells non-chemical products (articles) and is therefore not obliged to register or notify the European Chemical Agency (ECHA). AGRO AG expects its suppliers to act in accordance with the requirements of REACH.

The ECHA published the last update of the list of Substances of Very High Concern (SVHC) on 05.11.2025 in accordance with Regulation 1907/2006 on its website: <https://echa.europa.eu/de/candidate-list-table>. Updates are made every six months.

We would like to point out that the following substances are on the SVHC list, which are contained in some elastomers in our products in a concentration greater than 0.1 percent by mass:

- **Bumetizole (CAS No. 3896-11-5)**
- **Ethylenethiourea (CAS No. 96-45-7)**
- **Dodecamethylcyclohexasiloxane D6 (CAS No. 540-97-6)**
- **Dicumyl peroxide (CAS No. 80-43-3)**

The SVHC list is a candidate list for Annex XIV of the REACH Regulation. However, the fact that a substance is on the SVHC list does not mean that this chemical is no longer REACH compliant. It merely means that the candidate substance has been classified as a substance of very high concern by the submitting EU Member State or ECHA and may entail certain legal obligations for importers, producers and suppliers of the substance. However, it is important to note that the use of substances on the SVHC list may be restricted.

Based on the information available to us from the material suppliers and their data sheets, we currently assume that our products do not contain any other substances from the list of restricted substances in a concentration of more than 0.1% by mass.

AGRO AG monitors the updates to the ECHA list of substances of very high concern (SVHC) every six months.

In accordance with Article 33 of the REACH Regulation, we would also like to point out that our brass cable glands and their accessories may contain **lead (CAS No. 7439-92-1)** as an alloy component in a concentration higher than 0.1% by mass. Under normal and reasonably foreseeable conditions of use, lead cannot be released and therefore requires no additional instructions for safe use.

All AGRO AG products are compliant with Annex XVII of Regulation (EC) 1907/2006.
